REGULATION

for conducting of summer clinical training
for 3rd and 4th year students, specialty „Medicine“
for the 2025/2026 academic year

1. The summer clinical training is conducted in the period from 27th July 2026 till 25th August 2026 for 30 calendar days. 15 calendar days should be at an internal department and 15 calendar days at a surgical department.
2. The summer clinical training is conducted at the university hospitals in compliance with an approved schedule by the Dean of Faculty of Medicine.
3. The clinical training is conducted under the direct guidance and control of the person in charge (or substitute) in the respective department/section. The person in charge of the clinical training exercises control over the practical skills acquired by the students
4. Every student should register the performed manipulations in a „Diary” for the already conducted summer clinical training.
5. Apart from the university hospitals the students are allowed to conduct their clinical training in the specified period at other multidisciplinary hospitals for active treatment with an internal and surgical department in Bulgaria or abroad. Students who work in hospitals and have an employment contract will be able to register the training, presenting a certificate from the respective medical institution.
6. Students who would like to conduct their training outside the approved university hospitals, are obliged to submit an application form to the Dean of Faculty of Medicine from **20th April** till **15th May 2026** including.

7. When enrolling for the next year of study the students must submit at the Registrar's office of the Faculty of Medicine the certified diary and the student book (according to article 125 paragraph 1 from the Regulation for organization of the educational activities at Medical University - Plovdiv).
8. Students who have completed their clinical training outside the university hospitals, should present a certified diary and a certificate for conducted summer clinical training when enrolling for the next year of study.

The certificate must contain the following details:

- Name of student;
 - Period of conducting the training;
 - Name and address of the medical institution;
 - Clinical unit;
 - Name and signature of an authorized person;
 - Seal of the medical institution/clinical unit
9. A student with uncertified clinical training and not presented diary at the Registrar's office of the Faculty of Medicine is not allowed to enroll for the next year of study (*according to article 125 paragraph 2 from the Regulation for organization of the educational activities at Medical University - Plovdiv*).
 10. Enrollment for the next year of study is done not later than two weeks after the beginning the new academic year (*according to article 64 paragraph 1 from the Regulation for organization of the educational activities at Medical University - Plovdiv*).
